



# What are Key Conversations/Deliberations?

# **Key Conversations/Deliberations:**

Sequences of exchange and communication in which people engage to reduce the unpredictability and ambiguity of issues that are critical to moving the work forward

# **Designing Deliberations**

Key Conversations/Deliberations are patterns of exchange and communication in which people engage to reduce the uncertainty and ambiguity of issues that are critical to moving the work forward



The initiating step in determining a work unit's key conversations/ deliberations is to identify the **Topics** or issues about which people must reflect and communicate.

Once the key **Topics** have been identified, these elements will need to be addressed ...

- Participants Critical stakeholders to the issue; those who should be involved in the reflections and conversations; representative diversity of roles and perspectives
- Data the information that is needed to effectively address the topic and advance the reflections and communication; physical documents and stored information; data bases; analytics, algorithms and machine learning
- Forums in which they occur which may be structured, semistructured, unstructured or ad hoc; in person or online meetings; informal interactions; internet collaboration platforms
